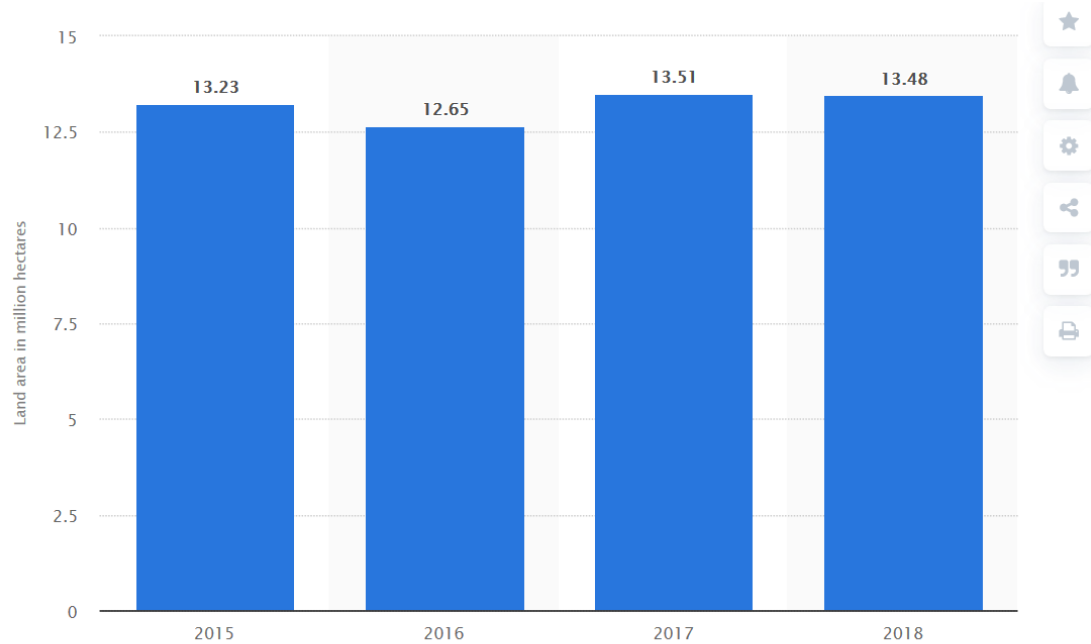

# Yield Loss due to Pest and Diseases

# 30 – 40 %

Globally, farmers lose 30 to 40 percent of their crops due to pests and diseases, according to the UN Food and Agricultural Organization

To help reduce these losses, farmers use an approach known as Integrated Pest Management (IPM)

- Range of management practices using simple approaches that reduce the incidence of pests and diseases on the farm

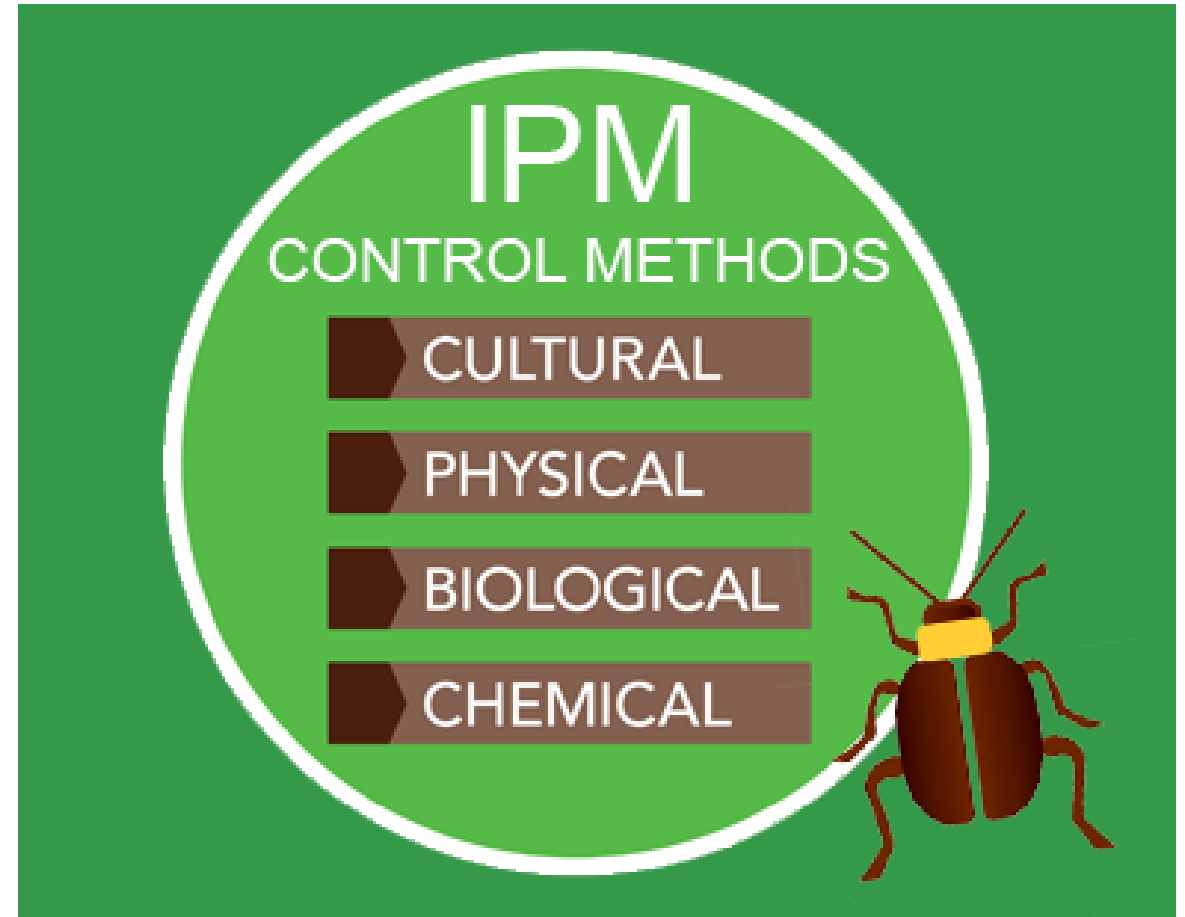
**INTERVENE**

- Determine the most appropriate intervention to control pests; one that is cost-effective and environmentally sound
- Interventions can be physical, cultural, biological or chemical
- If crop protection products are required, use them responsibly

# Integrated Pest Management (IPM)

- IPM programs combine management approaches for greater effectiveness
- The most effective, long-term way to manage pests is by using a combination of methods that work better together than separately.





# Integrated Pest Management (IPM)

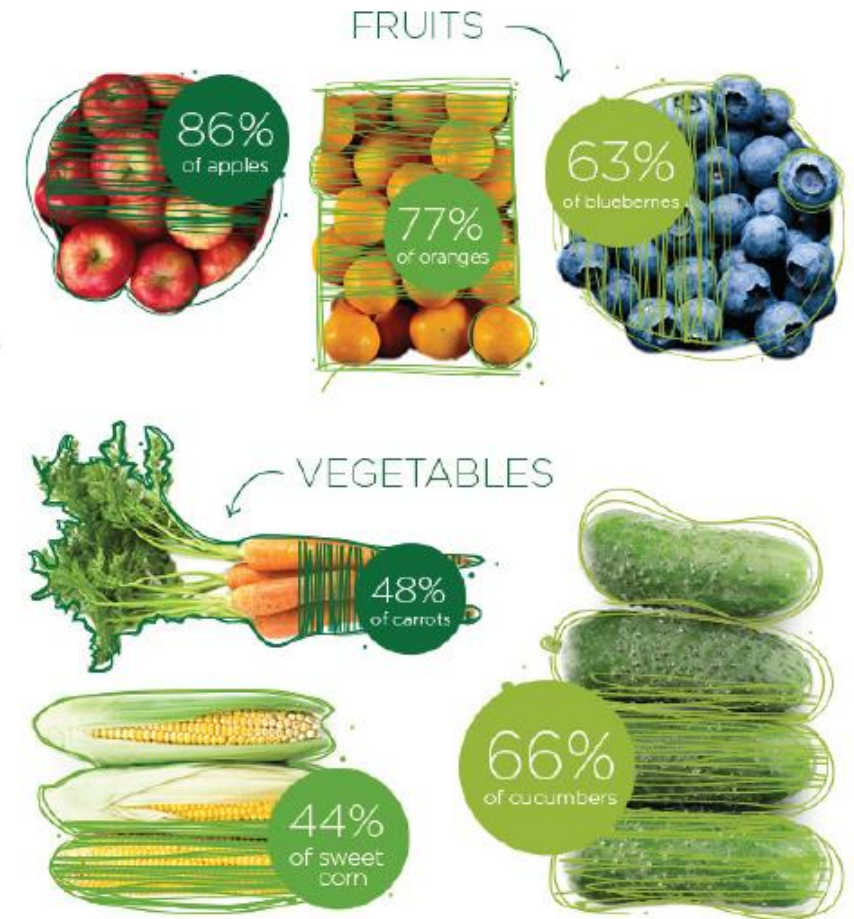
- Cultural – manipulation of cultural practices to the disadvantage of the pest
- Physical – techniques that limit pest access to the crop, induce behavioral changes or cause direct pest damage/death
- Biological – use living organisms such as predators, parasites, pathogens and competitors to manage pests
- Chemical – use of crop protection products or pesticides to help control insects, diseases, weeds, fungi and other undesirable pests.

# Chemical Control

Three main categories of Chemical control:

- **Herbicides:** These kill or stop the growth of unwanted weeds. Worldwide, farmers have to contend with more than **30,000 species of weeds** which fight with food crops for space, water and soil nutrients.
- **Insecticides:** These kill insects and mites. More than **10,000 species of plant-eating insects** and **3,000 species of roundworms** can attack farmers' crops around the world leaving food damaged and inedible.
- **Fungicides:** These destroy or prevent the growth of disease-causing fungi. There are more than **50,000 diseases** that get inside crops and poison or kill plant
